Cas (C) No. 296/2021 out of WA No. 24/2021 alongwith I.A.(Civil)/258/2021 and Govt. in Elementary Education Department, Assam instruction vide No. PMA.68/2021/103 dated 08/10/2021; online applications are hereby invited through the official website of DEE, Assam, i.e. <https://dee.assam.gov.in> **only from the writ petitioners** involved in the concerned WP(C)s and fulfilling all other eligibility criteria for filling up of remaining vacant posts against Advertisement dated 11/09/2020 for the post of **Assistant Teacher of LP Schools and Assistant Teacher of UP Schools** under the Directorate of Elementary Education, Assam.

The writ petitioners are requested to visit the official website of DEE, Assam i.e. <https://dee.assam.gov.in> and fill up the online application form and upload the following documents from the **Midnight of 25<sup>th</sup> May, 2022 to the Midnight of 25<sup>th</sup> June, 2022**.

Any other required details regarding this advertisement will be uploaded in the official website of DEE, Assam, i.e. <https://dee.assam.gov.in> before opening of the online application system.

**The writ petitioners must mention the WP(C) number and the Sl. No. of his/ her name in the Writ Petition in the relevant fields while submitting online application and the selection will be done in compliance of the final order and directions of the Hon'ble Gauhati High Court in WA No. 24/2021.**

Those who have already submitted offline documents in the office of the undersigned also need to apply.

**A. Scanned Documents required to be uploaded in colour:**

- i. Passport Size Photograph.
- ii. HSLC Admit Card/ Birth Certificate.
- iii. HSSLC Mark-sheet and Certificate.
- iv. Degree Mark-sheet and Certificate.
- v. Any other Mark-sheet and Certificate of higher education.
- vi. DEEd/ BEd Marksheet (1st Year & 2nd Year) and Certificate.
- vii. Caste Certificate (in case of SC/ ST(P)/ST(H)/OBC/MOBC).
- viii. Certificate NCC (Only B or C Category only), Sports & Cultural (if represented state at National Level).
- ix. Certificate and Mark sheet of TET.
- x. Candidates with disabilities will have to enclose valid certificates of benchmark disabilities issued by competent authority.
- xi. Certificate of Economically Weaker Sections (EWS) issued by appropriate authority.
- xii. Certificate of Ex-servicemen issued by the Director, Sainik Welfare Board.
- xiii. Scanned Signature.

**B. Criteria:**

1. **The Online Application and documents submitted by the candidate will be verified with the help of DigiLocker, Govt. of India and by scanning Barcode or QR Code for ensuring genuineness of the uploaded documents as well as by back-office verification with the competent board/ council/ authority. But the authority if desires may conduct physical document verification at any point of time with proper notice.**
2. **The candidate must ensure genuineness of all the information/ documents uploaded against the online application and he/ she will be solely responsible for the information/ documents uploaded against his/ her online application. Once uploaded there will be no scope of correction in respect of the credentials submitted by the candidates. Any discrepancy/ misrepresentation of facts/ information will lead to cancellation of the candidature.**

3. The candidature will be cancelled forthwith, if any kind of fraudulence/ discrepancy/ misrepresentation of facts/ uploaded by the candidate is established by appropriate authority at any point of time. The candidate will also be barred from taking part in any Govt. recruitment process in future and subsequent legal action will also be initiated against such candidate. The candidates should be cautious while submitting the online application as once the online application is submitted against a particular Roll Number of TET examination, they will not be allowed to submit the online application for second time.
4. D.El.Ed. with NC (Not Clear) status will not be eligible to apply.
5. After submitting the online application, the candidates will get a Unique Number against the submitted application and will keep the printout of the unique Number for all future references.
6. Canvassing directly or indirectly will lead to cancellation of candidature.
7. The office will not be responsible for any lapse in submission of online application due to any technical problem at the end of the candidate.
8. The eligibility criteria specified in the Advertisement dated 11/09/2020 will be applicable except the criteria of Assam TET and all other eligibility criteria must have been obtained on or before the last date of submission of online application as per the said advertisement dated 11/09/2020.
