It is for information of all candidates, who have successfully submitted online application in the official website of DEE, Assam, i.e. <https://dee.assam.gov.in> and received the acknowledgement against the Advertisement vide No. EAA/SIU/125/2021/Pt-I/39 dated 18/09/2021 for the post of Assistant Teacher of LP Schools and Assistant Teacher, Science Teacher, Assamese Language Teacher, Manipuri Language Teacher of UP Schools that the 3<sup>rd</sup> Provisional Merit List has been published on 27/04/2022.

1. Any adverse report resulting from the on-going Back-Office Verification of the uploaded documents, from the competent issuing authorities, regarding fake or forged documents submitted by the candidates, will automatically lead to cancellation of candidature forthwith as mentioned in the advertisement.
2. The Provisional Merit List/s will automatically stand cancelled on publication of the Final Select List. Appointment letters will be issued only to the candidates whose names appear in the Final Select List.
3. Any claim for appointment on the basis of Provisional Merit List/s will not be entertained.
4. The candidate whose name appear in the 3<sup>rd</sup> Provisional Merit List will be allowed to login in the portal with their credentials and will be able to submit the option if they have been selected in multiple posts from 12:00 noon to 12:00 midnight of 28/04/2022.
5. Back-office Verification is under process for the withheld candidates of the 3<sup>rd</sup> Provisional Merit List and therefore they need not visit the Directorate in respect of the same.
6. A **Physical Document Verification** has been scheduled only for some candidates and the list of the candidates will be published shortly on the website. Those candidates need to be present as per the Venue, Date and Time as follows:
