Primary school-000-(No Sub-Sub Head)-02-Wages-99-Others EE GA V. The salary of contractual teachers under SSA will be paid as earlier through SSA.
5. After merger the senior most Headmaster shall be the Headmaster of the school, if the date of joining happen to be the same then seniority in age shall be taken in to consideration of the seniority. The others Headmaster shall be the ex-officio Headmaster with the post personal to him and he/she shall continue to get his/her pay in the existing status till retirement or till posting elsewhere.
6. The excess teaching staff shall be posted elsewhere with-post or against vacant post with the protection of their seniority in the earlier school. The non teaching employees of the base school will continue in the school for the time being and excess non teaching employee of merged school shall be posted elsewhere.
7. After merger, the teacher of the merged school shall take classes from class VI to VIII.
8. After merger, School Managing Committee (SMC) of the new schools shall be reconstituted as per existing Govt. guidelines.



2. After amalgamation, the name of the schools shall be as mentioned in Columns 14 of Annexure-C respectively.
3. The post held by the employees including the vacant posts of the merged schools shall be the posts/ employee of the base (new) schools. The details of posts/ employees are mention in Annexure -D.
4. (i) In Case of ME School is base School, the salary of the regular employees will be paid under the Head of Account " 2202- Gen-Edu-01-Ele-Edu-101-Govt. Primary schools-0165-Govt. Primary school-000-(No Sub-Sub Head)-01-Salaries-00-(No Sub Detail Head) and the wages of the newly provincialised tutors and newly accommodated teachers will be paid under the Head of Account " 2202- Gen-Edu-01-Ele-Edu-101-Govt. Primary schools-0165-Govt. Primary school-000-(No Sub-Sub Head)-02-Wages-99-Others EE GAV. The salary of contractual teachers under SSA will be paid as earlier through SSA.

(ii) In Case of LP School is Base School, the salary of the regular employees will be paid under the Head of Account " 2202- Gen-Edu-01-Ele-Edu-101-Govt. Primary schools-0166-Govt. Primary school-000-(No Sub-Sub Head)-01-Salaries-00-(No Sub Detail Head). The wages of the newly provincialised tutors and newly accommodated tutor will be paid under the Head of Account " 2202- Gen-Edu-01-Ele-Edu-101-Govt. Primary schools-0166-Govt. Primary school-000-(No Sub-Sub Head)-02-Wages-99-Others EE GAV. The salary of contractual teachers under SSA will be paid as earlier through SSA.

5. After Amalgamation, the teacher of the Amalgamated school the LP teachers shall take classes from class I to V and UP teachers shall take classes from class I to VIII.
6. After Amalgamation, School Managing Committee (SMC) of the new schools shall be reconstituted as per existing Govt. guidelines.
7. The movable/ immovable property / documents/ records of the Amalgamated schools shall be vested in the name of Base (new) School.
8. In case one or more LP and one or more ME schools are amalgamated, the Assistant Teacher of the LP school shall be the employee of the amalgamated school and the Headmaster of the ME school shall be the Headmaster of the amalgamated school. The staff pattern shall be fixed as per existing norms for a ME School and the excess teaching employee shall be posted elsewhere against any vacant post with their seniority of the earlier school. There shall not be any financial loss and whatever emolument they are getting shall continue. The Head teacher of the LP school shall continue to draw charge allowance till his retirement or till his posting elsewhere.
9. The Assistant Teacher/Tutor and other staff of the school shall be the employee of the base school. The excess teaching and non-teaching employee shall be posted elsewhere against vacant posts with their seniority of the earlier school.
10. Gradation list: Each of the teachers shall be the teacher of the higher school after amalgamation and their status will be revised. After amalgamation the gradation list of School or District, as the case may be, has to be revised incorporating the names of teachers against the higher school in accordance with his/her qualification and status. He/she will get the seniority as before, and his/her name has to be placed in the appropriate place, in such a way that he /she does not lose his/her seniority.

The school authority, however, in case of any dispute arising out of the order, aggrieved institutions/public may appeal before the Government in the Elementary Education Department for adjudication.
