ORDER

In pursuance of the approval of District Level Committee of the **LAKHIMPUR** District and subsequent approval of the Department of School Education, Govt. of Assam vide No. E-250013 dtd. 07/08/2023; the following Assistant Teachers of **Lower Primary and Upper Primary Schools** under **LAKHIMPUR** District are hereby transferred with post within the same district in the interest of the students in compliance with the Right to Education Act, 2009 and as per the provisions of the Govt. Office Memorandum on Rationalization vide No-216176, dated-05/05/2023, at their own Grade and Pay and other allowances as admissible under the rules.

The regular teachers will join in their new places of posting as shown below. They must join in their new place of posting within 7 (Seven) days from the date of issue of this order.

The teacher is required to update his/her profile in the **Siksha Setu and hrmsassam.in portal** within 5 days of his/her joining in the new school, failing which his/her Transfer Order will automatically stand cancelled and he/she will have to return back to the earlier working school.

No TA/DA is admissible for this purpose.
