ORDER

Read: The Advertisement B vide No. EAA/SIU/125/2020/43 Dated 11/09/2020, wherein it is mentioned that the candidature will be cancelled forthwith, if any kind of fraudulence /discrepancy regarding any information/documents uploaded by the candidates is established by appropriate authority at any point of time. The candidate will also be barred from taking part in any Govt. recruitment process in future and subsequent legal actions will also be initiated against such candidates.

Read: The name of the candidate, **Dipika Baishya** bearing Application No. **2042045** in Upper Primary Category was kept withheld in the Final select list of recruitment process in Nagaon district of Regular teachers of UPS against Advertisement B vide No. EAA/SIU/125/2020/43 Dated 11/09/2020.

Read: The candidates who were marked withheld in the Final Select list were called for verification on the dated 08/02/2021 with all their original documents vide this office notice No. EAA/SIU/125/2020/191, dtd. 06/02/2021.

Read: After verification of original documents, it is found that the documents of **Bachelor of Arts** certificates under Janardan Rai Nagar Rajasthan Vidyapeeth University as submitted by Dipika Baishya bearing Application No. 2042045 is doubtful.

Read: Accordingly, this Directorate has called for a verification report from the Registrar, Janardan Rai Nagar Rajasthan Vidyapeeth University, Rajasthan vide this office letter No. EAA/SIU/125/2020/Pt-II/608, dated 23/02/2021 for verification of the documents of **Bachelor of Arts** Certificates as submitted by Dipika Baishya for back-office-verification.

Read: The Director, Directorate of Distance Education, Janardan Rai Nagar Rajasthan Vidyapeeth (Deemed to be University), Rajasthan has submitted a verification report in respect of Dipika Baishya and stated the vide his letter No. JRN RVU/DDE/2021-22/036, dated 07/04/2021 - "The Degree Certificate and Marksheet were not issued by the University, It is found not genuine".

Findings: As revealed from all the above Dipika Baishya had submitted fake Mark-sheet and Certificate of Bachelor of Arts against his online application for the post of Assistant Teacher for UPS and against his Application No. 2042045 and misled the undersigned appointing authority, i.e. DEE, Assam.

Order: On the basis of the above findings:
