However, **the Final Result of the selection process (Final Select List) will be declared after receiving the leave of the Hon'ble High Court.**

The candidates can't claim for appointment in the post of regular teacher based upon the fact that their names have appeared in the Provisional Select List. The Provisional Select List is published only for accepting any claims and objections from the candidates. There may be more than one Provisional Select Lists based upon the claims and objections received from the candidates. **The Provisional Select List will not be considered as the Final Result of the selection process (Final Select List).**



