Consequent upon notification issued vide No. PMA. 375/2017/44 dated 12th May, 2017, The Assam Education (Provincialisation of Services of Teachers & Re-organisation of Educational Institutions) Act, 2017" (Assam Act No. XXV of 2017) has come into force (except the provision under section 4 and 8) w.e.f. 5th May, 2017.

As per Govt. Office Memorandum letter dated 12th May, 2017 vide Memo No. PMA.375/2017/45-A, application forms the eligible Venture Lower Primary Schools / Upper Primary Schools for consideration of Provincialisation of the services of the eligible teacher / tutor serving in their institutions are hereby invited as per prescribed format of application as at Annexure-A in case of Lower Primary Schools, Annexure-B in case of Upper Primary Schools.

- The application forms as prescribed by the Govt. shall be made available in the office of the
 District Elementary Education Officers / Deputy Inspector of Schools for all district
 including BTC and Hills Districts and also available in the website <u>www.lpupteachers.com</u>
 on or before 19th May, 2017.
- 2. The concerned Head of the Venture Educational Institutions shall submit the application duly filled in with copy of all required documents to their respective District Elementary Education Officer alongwith a copy of Treasury Challan / Bank Draft of Rs. 100/- (Rs. One Hundred) only being application fee within 05.06.2017. No application form of any Venture Educational Institution shall be received thereafter. The Institutions which fail to submit application alongwith required documents or submit such applications with incomplete information shall be rejected without assigning any reason whatsoever and such institution shall be treated as not eligible under the purview of the Act.
- 3. The District Scrutiny Committee as required under section 13(4) of the Act shall be constituted within 25.05.2017.
- 4. The District Scrutiny Committee as constituted under section 13(4) of the Act shall thereafter proceed to scrutinize the service records and will prepare a list of all eligible employees in respect of each of the eligible Venture Educational Institution, who are eligible to get their services provincialized under the Act and shall submit within 20.07.2017 to the Director of Elementary Education, Assam with detailed information viz. educational qualification, date of birth, date of joining etc.
- 5. On receipt of the recommendation of the District Scrutiny Committee, the State Level Scrutiny Committee as constituted under section 13 (10) of the Act after physical verification and inspection of the Venture Institutions as may be required, shall submit the final recommendation within 31.08.2017.
- The Director of Elementary Education, Assam thereafter shall proceed to submit proposals
 for creation of posts for provincialisation of the services of the eligible teacher/tutor within
 10.09.2017 to the Government in the Elementary Education, Assam.

7. The Government shall proceed to create the required posts and issue notification for provincialisation of services of teacher/tutor immediately.
